Accompanying this letter is the proposed 2023 Annual Budget for the Lamar Redevelopment Authority Board. The budget has been developed with the participation of the Authority Board, the City Treasurer and management to provide the financial resources to meet the goals identified by the board.

By Ordinance of the City of Lamar, the goals of the Lamar Redevelopment Authority are to reduce, eliminate and prevent the spread of blight within the City's core downtown retail area and to stimulate growth and investment within the Area. It is the desire of the Authority Board and City staff to work cooperatively with other similarly motivated groups, organizations and individuals in the City, the County of Prowers and the State of Colorado to stimulate growth and investment within the defined Planning Area.

2023 will be the thirteenth year of actual operations for the Lamar Redevelopment Authority. Since its' inception, the Board has worked to refine its' focus to become more effective at making strategic investments in the Planning Area, searching for the key to igniting the spark of revitalization. Studies and anecdotal evidence both demonstrate that the City's once dominant downtown retail market is losing out to other regional hubs like Pueblo and Garden City and to the Internet. Many outside studies have been conducted; much public comment has been solicited and offered; the prevailing judgment is that the downtown retail environment is currently out of step with modern marketing concepts and no longer offers an attractive shopping destination for younger more mobile and internet-savvy consumers. The City's retail center is badly in need of a "refresh."

The 2023 budget for the Authority projects revenues of \$255,000 which is a slight increase over the \$244,975 of revenue budgeted for 2022 due to the decision to use fund balance for anticipated incentives. Despite 13 years of work, progress has been slow and there continues to be a significant number of vacant storefronts. The authority is budgeted to expend \$255,000 in 2023 yielding a deficit of \$64,060. There is a significant Fund Balance in the LRA Fund that will cover the deficit, and as revitalization efforts in the District gain traction, continued deficit spending may be planned in order to put the excess funds to produce use for the benefit of all.

2023 will see the beginning construction phase of the long-awaited Main Café project. In conjunction with the City of Lamar, The Lamar Redevelopment Authority, the Lamar Main Street Organization and other partners have invested significant funds, time, and effort into upgrading this historical downtown building. The Lamar Redevelopment Authority Board has committed to using its available funding, including the accumulated Fund Balance, to make sure this, and other investments are accomplished.

The City Treasurer, the City Council and City staff have all worked to make the 2023 planning and budget development process meaningful and successful. I extend my sincere thanks to all of you for your efforts and look forward to success and progress.
